## Legal Advice service

We continue to look for opportunities **to promote our members legitimate business interests** in Poland, both through active participation in the work of the SPCC Board and our own distinct activities. Popular FTG events such as the *Summer Picnic* and the *Independence Day's Night* continue to be important in bringing a large number of our members, business partners and friends of Finland together and in enhancing **social and business networking.** 

## Membership growth strengthens the voice of Finnish business community

FTG has an important and distinct role to play in bringing the Finnish business community and friends of Finland in Poland together, providing also a Finnish context and edge to their SPCC membership. This the FTG Board will continue building on, with the crucial support of our corporate sponsors and in cooperation with our members.

In 2016 FTG was the **fastest growing national section** in SPCC both in absolute and relative terms, with a net gain of 3 corporate members. At the end of 2016 we had an **all time high of 72 members (out of which 67 corporate member)**, up from 49 (45) at the beginning of 2010. This equals to ca. 32 % of the total number of Finnish businesses operating in Poland.

While this is a high percentage compared to the other SPCC national sections, there is still potential for us to grow in order to strengthen the voice of the Finnish business community in Poland. As existing members we are best placed to spread the word of all the FTG/SPCC membership benefits to potential new members, whether clients, partners, vendors or service providers to our business.
