**ISI DealWatch releases League Tables for Top M&A Financial Advisers and Top M&A Legal Advisers in Poland, for January 2008-March 2009**

*DealWatch LeagueBoard reports on Financial and Legal Adviser activity in M&A transactions*

Warsaw, June 3, 2009 - According to the DealWatch database, ABN Amro was the Top M&A Financial Adviser, while Domański, Zakrzewski, Palinka was the Top M&A Legal Adviser in Poland in Jan 2008-Mar 2009, in terms of total deal value. On the other hand, Deloitte Touch Tohmatsu and Weil, Gotshal&Manges topped the rankings of financial and legal advisers, respectively, in terms of total deal number.

In Central and Eastern Europe, Merrill Lynch was the Top M&A Financial Adviser in Jan 2008-Mar 2009 period, while Clifford Chance was the Top M&A Legal Adviser in terms of total deal value. Deloitte Touche Tohmatsu and White&Case topped the rankings of financial and legal advisers, respectively, in terms of total deal number.
